**1.** One (1) complete set of plans and specifications for proposed work shall be included with BUILDING PERMIT APPLICATION. Those plans and specifications shall be in accordance with the State Education Law, §7307 and §7209. This law requires that the seal and signature of a licensed architect or professional engineer to be affixed to all plans submitted EXCEPT for farmbuildings, residential buildings under 1500 sq. ft. or alterations costing LESS than \$20,000.00. Where work consists of MINOR alterations the applicant may request waiving the submission of plans.

**2.** The application shall notify the Building and Fire Inspector of any changes in the information contained in the application during the period for which the permit is in effect.

**3.** A building permit issued pursuant to this shall be prominently displayed on the property or premises to which it pertains.

**4.** A building permit issued pursuant to this part may be suspended or revoked if it is determined that the work to which it pertains is NOT proceeding in conformance with the Uniform Fire Prevention and Building Code or with any condition attached to such permit, or if there has been misrepresentation or falsification of a material fact in connection with the application for the permit.

**5.** A building permit issued pursuant to this part shall expire three (3) years from the date of issuance or upon issuance of a certificate of occupancy other than a "temporary" certificate occupancy. The permit may be renewed for one (1) year if a renewal fee of 50% of the original building permit fee is paid and the original permit has not been suspended or revoked.
