YOUTH MEMBERSHIP APPLICATION AND LIABILITY WAIVER

I, _____ (Name of Releaser), hereby acknowledge that I have voluntarily applied for my youth, _____ (Name of Youth), to participate in activities or events which are sponsored, authorized or run by the Nubian Empire Ski Club, Inc., hereinafter referred to as "NESC". These events and activities may include but are not limited to the following: snowboarding/snow skiing, snow board/ski training or instruction, ice-skating, sledding, parties, social events or functions, dinners, games, sports and recreational activities, raffles, fund-raising activities, promotional activities, gatherings, dances, meetings and all activities and functions of any kind or manner which are sponsored, operated, managed or promoted by NESC.

- 1. I am aware that winter-sports such as ice-skating, sledding, snowboard/ski instruction and snowboard/ski training and snowboarding/skiing in general are hazardous activities and involve a great deal of risk and of physical injury. I know that there are natural and man-made obstacles or hazards, surface and environmental conditions, and other risks, which in combination with my actions or the actions of others can cause me very severe and/or fatal injury and /or property damage. I understand that snowboarding/ skiing and snowboard/snow ski racing are inherently dangerous activities and I voluntarily assume the risk of all course conditions and any and all risk of injury and/or death or property damage.
- 2. In lawful consideration of being permitted by NESC, employees, agents and volunteers to participate in snowboard/snow skiing, snowboard/ski training or instruction, or any other activities, I hereby agree that I, my heirs, distributees, guardians, legal representatives and assigns will not make claim against, sue or attach the property of, or prosecute NESC and/or any of its affiliated organizations, employees, agents, volunteers for injury or damage resulting from the negligence of or other act howsoever caused by any employee, agent, volunteer or contractor of NESC or its affiliates as a result of my participation in any snowboarding/ skiing activities or other event sponsored by NESC or its affiliates. In addition, I hereby release and discharge NESC and its affiliated organizations, employees, agents and volunteers from all actions, claims or demands that I, my heirs, distributees, guardians, legal representatives or assigns my now have or hereafter have for injury or damage or even death resulting from my participation in any activity related to any snowboarding/ skiing, training or instruction or any other event sponsored in whole or in part by NESC and/or its affiliates. I also waive and release any claim that I may have against NESC, its affiliates, organizations, employees, agents and volunteers from any claim based upon negligence or breach of warranty. I agree to indemnify NESC for any and all claims brought by a third party, which I may cause.
- 3. I expressly agree that the foregoing release, waiver and indemnity agreement is intended to be as broad and as inclusive as is permitted by the law and that if any portion of it is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.
- 4. I hereby acknowledge that my membership in NESC does not in any way include or guarantee to me any insurance coverage of any kind.
- 5. I authorize any RELEASED PARTY and/or their authorized personnel to call for medical care for the participant or to transport the participant to a medical facility or hospital if, in the opinion of such personnel, medical attention is needed. I further agree that upon transport to any such medical facility, NESC will have no further responsibility to me and will not be responsible for any costs associated with treatment received by me.
- 6. I am signing this liability release on behalf of a minor less than eighteen (18) years of age (the child), I represent that I am the parent and/or legal guardian of such child; I accept responsibility for all of the child's medical expenses incurred in connection with any snowboarding/skiing or related events or activities sponsored by NESC or its affiliates. Furthermore, I agree to indemnify NESC for any and all claims brought by the child and I agree to indemnify NESC for any and all claims brought by a third party arising in connection with the child.

I HAVE CAREFULLY READ THE FOREGOING LIABILITY RELEASE, UNDERSTAND ITS CONTENTS, AND AM AWARE THAT I AM RELEASING CERTAIN LEGAL RIGHTS THAT I AND/OR MY MINOR CHILD MAY HAVE.
