

**Articles of Incorporation  
of

A Non-Profit Corporation**

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

**Article 1**

The name of this corporation is the Coronado Neighborhood Association.

**Article 2**

The name and address of the registered agent and registered office of this corporation is:

**Article 3**

The purposes for which this corporation is organized are:

1. To expand opportunities participation and cooperation among residents and agencies serving the designated neighborhood association area.
2. To research, evaluate and recommend ways to meet community needs.
3. To provide greater information to residents of the area and to increase visibility and participation its members to maximize their effectiveness.
4. To empower residents to plan, develop, implement and take action on issues pertinent to its members.
5. To facilitate the shift towards the community identifying resources and assets.
6. To provide, communicate, and promote findings of research and surveys on issues to the community.
7. To provide community members with a voice in identifying and addressing issues in the area.

8. To seek funds and other resources to improve the quality of residents in the area.

The number of initial directors of this corporation shall be 4 and the names and addresses of the initial directors are as follows:

The duration of this corporation shall be perpetual.

#### **Article 7**

The corporation shall have only one class of members. No member shall hold more than one membership in the corporation. Except as expressly provided in or authorized by the Articles of Incorporation, the Bylaws of this corporation or provisions of law, all memberships shall have the same rights, privileges, restrictions and conditions.

#### **Article 8**

A director is not liable to the Corporation for monetary damages for an act or omission in the director's capacity as director except to the extent otherwise provided by statute of the State of Texas.

#### **Article 9**

The Corporation may indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was a director or other person related to the Corporation as provided in the Bylaws, the

Board of Directors shall have power to define the requirements and limitations for the Corporation to indemnify directors, officers, or others related to the Corporation.

The Board of Directors of the Corporation shall have the power to adopt such initial Bylaws as may be deemed necessary and convenient for the proper government and management of the business and affairs of the corporation, but thereafter the Bylaws may be amended, altered or repealed by majority vote of the members of the corporation provided for in the Bylaws.
