## **THM Sadaqa Group Homeschool Assistance Program Textbook Rental Terms and Conditions**

1. This agreement exists between the customer (“you”) renting a set of textbooks (“the books”) and the THM Sadaqa Group Homeschool Assistance Program (“THM or InHouseGA”).
2. These sets of textbooks are not for sale. This is not a rent to own agreement. Ownership of the textbooks shall at all times remain with THM or InHouseGA.
3. This agreement expires on the date shown on the first page of this form. All conditions must be met and the textbooks returned to the homeschool program no later than seven (7) days from the expiration date. If you wish to continue renting the textbooks, a new rental agreement must be completed.
4. You may terminate this agreement at any time by returning the textbooks to the homeschool program. No refunds will be given. No party other than Saddiqua Muhammad Black is permitted to accept the return of the textbooks without prior authorization from the homeschool program. All conditions of returning the textbooks must be met in order for your responsibility to cease.
5. You are fully responsible for the safety of the textbooks. Rental fees are used to provide students with the required textbooks used for our programs. Repairs and maintenance include but are not limited to: deterioration of physical appearance such as scratches and imperfections in the cover, No writing, highlighting, markings or damage including moisture damage are allowed. **REPLACEMENT COSTS PLUS A \$25 Shipping & Handling fee WILL BE ASSESSED IN THE EVENT THE RENTAL BOOK IS MARKED OR DAMAGED.**
6. The textbooks must be checked by Ustadah Saddiqua Muhammad Black to ensure good condition and appearance prior to returning the textbooks regardless of length of rental agreement. Damages caused by any irresponsibility of the student will be handled at your expense by Ustadah Saddiqua. Any replacement charges totaling more than the rental fee will be the responsibility of the customer. All replacement charges must be paid in full at the time of the textbooks return.
7. I understand and authorize THM Sadaqa Group to place my student records on hold if the book is not returned by the last day of finals of the semester the rental occurs. Once a hold is placed it may take up to two weeks to be released. In addition, if my books are not returned by the deadline, I will not be eligible for this program in future semesters. Returning the rental books after this deadline does not remove my obligation to pay the replacement cost along with a \$25 shipping and handling fee.
8. In the event of damage beyond repair, estimated replacement charges beyond the value of the textbooks, or theft/loss of the textbook, you are liable and agree to pay THM or InHouseGA one-hundred (100%) percent of the retail value of a new textbook similar in specification to the one rented, regardless of the textbook’s age or condition. The homeschool program shall be the sole judge in all cases.
9. I understand that once processed, my rental fee is non-refundable.
