Eagle Point Bay Association Parks

Vandalism, littering, trespassing, unattended fires, disrespectful adolescents, and more! We are experiencing major trouble in our parks! Please read on, as we need your help to preserve our parks and keep your dues down. Here are some of the problems we face:

- **Vandals** have recently destroyed a picnic table and benches within the park.
- **Locks** have been cut to gain entry, and the gates have been damaged.
- Aluminum cans, bottles, and assorted **litter**, along with articles of clothing, have been left in the parks for others to clean up.
- **Fires** have been left burning overnight, the pit filled with beer cans and broken glass, to the extent that we have had to eliminate the fire pit in order to prevent damage to park attendees and neighboring properties.
- **Disrespectful adolescents** harass members who attempt to enjoy our parks.
- Teenagers/hoodlums are **partying** into the late hours, drinking alcohol, leaving their litter for others, and making noise, aggravating our members who live near the parks.
- **Non-members** have been taking advantage of our parks, leaving the gates open, taking up parking spaces meant for members, and **gaining access to private property at the boat slips**.

We need your help! Please observe the following rules:

1. **Lock the gate, both after you enter and again when you leave.** Do not leave the gate open while you are enjoying the park, as it allows entry to non-members.
2. If you see the gate open at any time, **lock it!** Do not worry about locking anyone in, as those who are in should have a key!
3. **Never loan your key** to anyone you have not listed on your membership form.
4. **Do not make copies of your key!**
5. Always **accompany your guests** to the parks. If you do not, they are trespassing and may be prosecuted.
6. **Know where your teenagers/young adults are at night.** If they are caught in the parks, they may be arrested. The Johnson County Sheriff's Office has been notified of our problems and do patrol the area.
7. **NO overnight parking** in park lots!
8. **Children** should always be supervised.
9. **Remind others** to follow these rules, especially when you see infractions.
10. **Do call the sheriff when you experience a problem at the parks.** The Johnson County Sheriff's phone number is 618-658-8264.

Total Eclipse of the Sun

During the total solar eclipse, on August 21, 2017, please be advised that the area of longest duration is just southeast of Carbondale. The eclipse will begin at approximately 11:50 a.m. and will end around 2:50 p.m., with the totality lasting 2 minutes, 41.6 seconds at that spot. It is important to use eclipse viewers except during the time of totality, when you may view the aura. Once the smallest portion of sun reappears, you must go back to using eclipse viewers. Supervise children to protect their vision! Viewers are available at many local locations. Be prepared for an influx of visitors to our area during the event. You may want to stock up on necessities prior to the 8-18-2017 weekend.
