Hartridge is an Equal Opportunity school and participates in a controlled enrollment process.

Hartridge Academy is a **FREE** public charter school of choice. We have public school transportation route which includes afterschool options. Most, if not all **families qualify for free or reduced meals and afterschool childcare.**

You may apply even if you already attend another school of choice.

The open enrollment period for our 2021-2022 school year is October 16, 2020- October 30, 2020. Applications **postmarked** during the open enrollment will be considered as received on one date, **October 30, 2020.** If the number of valid applications exceeds the number of spaces available for each grade or class, a random drawing will take place. A waiting pool will be created for remaining applicants. Parents should receive a letter or email confirming receipt of the application within four weeks of its arrival. Please call Hartridge if you do not receive an acknowledgement within four weeks.

During the enrollment period and throughout the year, priority for available spaces is given to: siblings of Hartridge students, Hartridge employees' and board members' children, and students living in the Lake Alfred, North Winter Haven, and Auburndale area. **If your application is randomly drawn, additional documentation will be required by us, the PCSB, and other agencies, at a later date for use during the conferences and/or registration period.**

The controlled enrollment statement on our website lists other priority groups per legislation. Enrollment will require a deadline and costs for specific documents, uniform purchase, and supplies.

Once a space is offered, you must respond as instructed on your notification or you will be removed from the pool and required to reapply. If you decline an offered position for your child at any time, you must send a new application for the waiting pool, should you desire a position in the future. Continued enrollment does not require reapplying.

Your child must have been born before September 2, 2016 to qualify for grade K-5. If your child is younger, please call 863-956-4434 for information regarding **FREE PRESCHOOL** opportunities.

A return address and postmark are required on your application.

Applications are discarded at the end of the school year. A new application is required each year until enrolled.

Your signature is required as acknowledgement that you have read both sides of this application.

IMPORTANT INFORMATION:

1. Only postmarked applications will be valid. No hand deliveries or courier services.
2. Applicants are screened for attendance, behavior, and potential for success in our program.
3. Enrollments are set by grade level and special programs such as gifted (alpha, etc.). Combination classes are available for accelerated students.
4. Until enrolled, students must reapply to the waiting pool, annually.
5. ESE classes may be limited.
6. Prior to acceptance, parents will agree via contract, to comply with all requirements set forth by Hartridge Academy, the PCSB, and state/federal requirements for public education.
7. It is the applicant's responsibility to make timely changes to contact information.
